THE FIRST BREATH PROGRAM HELPS PREGNANT WOMEN, NEW MOMS, AND THEIR FAMILY MEMBERS QUIT SMOKING. THIS PROGRAM IS A STATEWIDE PROGRAM THAT HAD 236 SITES DURING 2018. SITES CURRENTLY INCLUDE LOCAL PUBLIC HEALTH DEPARTMENTS, PRIVATE HEALTHCARE PROVIDERS, FEDERALLY-FUNDED COMMUNITY HEALTH CENTERS, AND TRIBAL HEALTH CLINICS. THERE WAS A TOTAL OF 1,326 WOMEN REACHED DURING 2018, BRINGING THE TOTAL NUMBER OF WOMEN SERVED TO ALMOST 22,000 CLIENTS SINCE 2000. FIRST BREATH FAMILIES IS FOCUSED ON HELPING WOMEN QUIT SMOKING DURING PREGNANCY AND STAY QUIT POSTPARTUM, PROMOTING SMOKE-FREE ENVIRONMENTS FOR WOMEN, CHILDREN, AND FAMILIES. THE MY BABY & ME PROGRAM IS A FETAL ALCOHOL SPECTRUM DISORDERS PREVENTION PROGRAM THAT HELPS WOMEN ACHIEVE ALCOHOL-FREE PREGNANCIES
